AIM of the Society

ACTIVITIES AT A GLANCE 2022-23 Period

- * The VoICE team had a VC meeting with Secretary Telecom on 6th January 2022 and that led to DoT's recommendations to the finance minister on usage of USOF fund to support R&D which later led to announcement of TTDF in October 2022 during IMC.
- * Based on USOF submissions, led to 4 Projects from USOF worth Rs. 10 Crores each to start-ups like Lekha Wireless, Signaltron, Resonous and Astrome.
- * In line with commitment made to Secretary (T), VoICE team was able to showcase live 4G/ 5G Consortium based complete end to end solution from 16 to 18 May 2022 at 13 Floor Sanchar Bhavan and included some live requirements for modernisation of Indian Railways.
- * VoICE made a presentation and participated in an international exhibition of IRSTE at Ambedkar International Hall wherein some more Railways' applications were added.
- * VoICE team was present in MEITI's event at Gandhinagar also on 4-5-6 July 2022.
- * End of July 2022, VoICE supported participation of around 24 exhibitors during DoT's Investor meet a Mumbai.
- On 8th August 2022, VoICE team showcased end to end 4G/5G solutions in Consortium mode during an ITU event at Hotel Lalit, New Delhi.
- * On 9th August 2022, VoICE team showcased end to end 4G/ 5G solutions in Consortium mode at 21 Signal Group, Anand Parvat, New Delhi. This led to many VoICE members directly interacting with 21 Signal Group for their requirements.

- * From 1st to 4th October 2022, VoICE consortium showcased at India Mobile Congress.
- * Communication Minister, Commerce Minister, Mining Minster and Shri PK Mishra, Principal Secretary to Prime Minister appreciated consolidated efforts put up by VoICE team with multiple players joining hands to present multiple end to end solutions covering Armed forces, Railways, disaster management, automobiles, mining, robotics, banking, finance, data centres etc in 5G Private Enterprise network solution.
- * It may be the first of its kind in the world and next 18 to 24 months' time at least 5 domestic players will be challenging globally Nokia, Ericsson. This was the statement made by Director General, VoICE to the Hon'ble Prime Minister in support his vision of India being a global hub and leader in Telecom technology.
- * Communication Minister had launched 25 new products from 19 companies at VoICE Consortium
- * Minister for Coal & Mines, Minister for Commerce & Trade, Army Chief and senior Army officials, Railway Board Chairman & senior Board members, very senior officials from Niti Ayog & other Ministries, Chairman of Reliance Jio & Airtel were amongst the visitors to see the Consortium based end to end results presented by VoICE team.
- Success of the IMC2022 can be seen as Indian Railways awarded India's first 5G Pilot Project to VoICE Consortium on Mathura Palwal Section of Indian Railways. 21 Signal Group also came up with a request on a Pilot Project.
- * VoICE team participated in Bangalore Tech summit in Consortium mode with about 20 companies participating.
- * There was participation in DoT's event at Bhubaneshwar.
- VoICE team with 25+ companies were part of India Telecom 2023 at Hotel Taj, New Delhi where 100+ foreign participants.
- * Along with TCIL, setting up of Training Centre facilities in 12 countries on 5G end to end solution was also proposed under TTDF.
- * Proposal to revive US \$ 1 Billion Line of Credit for ASEAN countries is also submitted.
- * Director General, VoICE was Chairman of Task Force constituted by the Government on New Opportunities on telecom equipment.
- Proposals on PLI, Public Procurement Make in India Policy, Standards & certification, MTCTE issues, custom & network security issues, policy violation interactions with multiple ministries and PSUs in line with VoICE activities are taken up as per requirements and submissions received from members.
- * More than 30 VoICE members are already part of complete 5G end to end solution capabilities and number is increasing each day.
- * Consortium of 23 VoICE companies making live 4G and 5G Private Enterprise network. The event IMC2022 was subsequently held at Pragati Maidan from 1st to 4th October 2022 and Hon'ble Prime Minister was with VoICE Consortium pavilion for about 8 minutes.
